<p>Expansion Committee Report</p>	<p>a. K-1 Grade Expansion for 22-23</p> <p>73% have responded with a yes. Need to hear from the 27% to know if they are coming back or not Adding kindergarten and 1st grade, with 3 in each level. One grade at 5th and 6th, 2 at level 2, 3, 4. 236 at full enrollment (ADM)</p> <p>Bond would be needed to buy out the lease, add gym and classrooms. To do this we would need about 840 ADM.</p> <p>b. Projected growth plan</p> <p>9.75 million to buy from Wellington Can get about 12 million if we Bond out now. But if we wait for larger enrollment we could get 5 million more. We are looking at making the area a campus for us and not having the strip mall still operating.</p> <p>c.
